TEACHING

- **PUBLHTLH 7040 Public Health Organization (3cr):** This was the first course I taught at OSU, and I completely redesigned this course from its previous instructor. It was the first courses taken by MPH-PEP students. My key goals were for students to understand the evolution of the public health system in the US, it's interaction with the healthcare system, and then apply that understanding to develop solutions that address "wicked problems." This course was stopped after 2020 and the content incorporated into the new college-wide integrated core. A summary of the overall instructor ratings is below. - **PUBHHMP 6620 Critical Appraisal of Population Health Evidence (3cr):** I created this course as part of the redesigned MPH-PEP curriculum and taught it for the first time in 2018. It was initially designed to be a synchronous online course, but I have since moved it asynchronous. **My goal for this course was to build off the student's skills at Evidence-Based Medicine to apply concepts from Evidence-Based Public Health in creating a recommendation to address a self-selected population health concern.**

- **PUBLHTLH 6002: The History, Values and Essential Services of Public Health (2cr):** I serve as course director for this course and teach one section (3 weeks) of content and led two of the three Integrated Labs. I led the process of creating the course, outlining the content and organization of the course, and oversaw the course's implementation. I oversaw the three course graduate teaching assistants and managed the course throughout the semester. I wrote the case discussions for the students to work with during the synchronous sessions and hosted both sessions. I continue to revise and oversee this course, working with faculty across the divisions to improve the alignment of content throughout the four Integrated Core courses. The first year of the course, AU 2021 had 155 students in the course.

- PUBHLTH 7996: Integrated Learning Experience (ILE) (Formerly called Culminating Project) Prep Seminar: This is a one-credit course where MPH-PEP students begin planning their ILE. When it began in 2017, I met with students individually to help them get started. I have increased my presence in the course over the years and now have a more robust synchronous and asynchronous experience for students online, and I meet with the small group at the beginning of the semester. The course has 3-5 students enrolled each semester.
